Chair Alex Martins called the Board of Trustees Meeting to order at 10:00 a.m.

He reminded the Board that the meeting was covered by the Florida Sunshine Law and that the public and press were invited to attend.

Lauren Ferguson, Assistant Vice President for Board Relations, called the roll and determined a quorum was present.

REMARKS

Martins provided remarks regarding UCF's record-setting Day of Giving and thanked members for their 100% participation. Martins noted the importance of the board providing leadership in university initiatives such as this.

President Cartwright also expressed his gratitude for the Trustees' participation and reviewed recent achievements at UCF, including Founders Day celebrations, the success of the Day of Giving, and philanthropic investments in UCF's mission. He discussed UCF's progress as a national university, emphasizing the significance of university partnerships. Cartwright also commented on improvements in graduation rates and student success.

Christy moved to approve BOT-1, the 2024 UCF Accountability Plan, with the opportunity for staff to make minor edits before submission to the Board of Governors, with Greenaway providing the second. The motion passed unanimously.

There was one request for public comments. The comment made by the speaker in virtual attendance was regarding the metrics in the UCF accountability plan.


